RULES & REGULATIONS  
FOR USE OF LGV SOCCER FIELD AND YSMAEL BAYSA SPORTS CENTER  
AT THE GARDENS FOR SPORTS RELATED ACTIVITIES

Usage/ Schedule/Time of Use:

4. The use of the LGV Soccer Field & Ysmael V. Baysa Sports Center at the Gardens is open to all LGVHAI resident members ONLY as well as their accompanied guests from Monday to Sunday, 7:00 a.m. – 9:00 p.m. only
5. The LGV affairs take precedence over the use of any of the LGV facilities.
6. The LGV Office will have to be informed ahead of time if the use of the facilities will go beyond 6:00 p.m.
7. Small private family parties/gatherings of residents will only limits as follows:
  - ) Weekdays – Mondays to Thursdays only
  - ) Weekend – party shall only be limited to once a month.

Reservation:

1. Reservations for the exclusive use of both facilities can be made at the LGV administration Office at least 3 days prior to the date of use. Accommodation of reservations will be done on a FIRST COME FIRST SERVE BASIS.
2. Rentals will be on an hourly basis. NO fractional minutes will be accepted, i.e. 15 minutes or 45 minutes will be considered as one (1) hour. Time schedules will be strictly enforced.
3. Pay necessary fees prior to the use of the facilities.
4. Rates for the use of the following facilities for sports related activities for his/her exclusive use, the corresponding fees will be charged and are as follows:
  - Ysmael Baysa Sports Center
    - P200.00 per hour – during the daytime
    - 500.00 per hour – after 6:00 p.m. (for the use of lights)
  - Soccer Field
    - P200.00 per hour – during the daytime
    - 400.00 per hour – after 6:00 p.m. (for the use of lights)

**Note:** NO exclusive use of facilities during Friday, Saturday and Sunday. Small private parties during weekends will be accepted only once a month with prior approval of the LGVHAI authorized officers.

Proper Decorum:

1. Players should wear proper playing attire/uniform (i.e. soccer/basketball jersey, rubber shoes etc.)
2. Users of both facilities are expected to behave properly by avoiding the following:
  - ) Unnecessary noise
  - ) Violent behavior
  - ) Damage to the facility and adjacent property.
3. Firearms and liquors are strictly prohibited inside the Gardens. Intoxicated or drunk persons are also not allowed inside and will be banned from using it again.
4. Users of both facilities should always keep the facilities clean and should throw their garbage into the garbage bins. Littering is strictly prohibited. The use of trash cans and receptacles are provided for within the premises.
5. Any willful loss, breakage or damage to the facilities brought about by any individual or group shall be assessed and billed against the party concerned.
6. LGVHAI shall not be held liable for any loss of valuables, or personal effects, or physical injuries suffered by any player resident, guest, or visitor during the use of both facilities.

LGVHAI RESERVES THE RIGHT TO STOP THE USE OF THE FACILITY AT ANYTIME IF ANY OF THE ABOVE RULES ARE VIOLATED.
